TUITION AND ACCEPTANCE INFORMATION

The Early Childhood Education Center currently offers seven classes of full day kindergarten and three classes of half day kindergarten. The half day kindergarten program is offered free of charge to all children who are 5 on or before September 1, 2012 and are residents of Dedham. The Full day kindergarten is supported in part by tuition. Full day kindergarten is the right match for many children who are ready to experience a longer day. It provides an opportunity to study the Dedham kindergarten curriculum, as well as time to practice skills learned and to engage in more social skill development.

- The Dedham Public Schools provides two and one-half hours free of charge. This is the regular kindergarten day for all children.
- The additional three hours and 40 minutes are financed by tuition.
- The 2011-2012 tuition is \$3,500.00. Tuition is subject to change for the 2012-2013 school year.
- Tuition is payable in weekly or monthly installments between May 2012 and January 2013.
- A lottery will be held on January 25, at 9:30 A.M. to select the individuals who will be placed in full day classes.
- Families may opt to use the sliding scales approved by the Dedham School Committee for a reduced tuition.

FULL DAY KINDERGARTEN LOTTERY REQUEST

Enrolling in the Full Day Kindergarten Lottery is by no means a binding commitment to enrolling your child in the full day program. If your child is offered a place in full day kindergarten you may make the decision at that point.
