Ms. White expressed her sincere gratitude to the School Committee and many community members for being the Chair of the School Committee this year (the following is Ms. White's statement):

Good evening,

As my last act of being the Chairperson of the Dedham Public Schools. I would like to take a moment to thank the voters for allowing me to continue to serve as an advocate for the students, families, and entire staff of the Dedham Public Schools.

I have been lucky enough to have had the pleasure to work with many different Chairpersons of the School Committee; Tom Ryan, Steven Bilafer, Susan Butler Walko, Kevin Coughlin, and Lisa Laprade.

They each taught me so much, whether they are aware or not. Superintendent's Update

Superintendent Welch provided the following update to the Committee:

Today was the 142nd day of classes for the 2021-22 school year. Students and faculty/staff were grateful for last week's annual 1-week April vacation. We have fewer than 8 weeks of school left. The last day of the school year is a half-day for students and is currently scheduled for Tuesday, June 21.

In December 2021, Governor Baker signed *An act concerning genocide education*. Beginning next school year, this legislation requires that districts provide instruction about the history of genocide to middle and high school students in a way that is aligned to the content standards laid out in the 2018 Massachusetts History and Social Science Framework. The Department recently released a **Genocide Education: Frequently Asked Questions document** (*download*) which includes additional guidance about the legislation, examples of how genocide education might be provided within various middle and high school courses, and links to resources. The district continues to aggressively pursue the appointment of district and school level administrative positions. As the Committee is aware, in the last week **Dr. Sara Stetson** was recently appointed as the district's Assistant Superintendent for Student Services beginning July 1, and **Ed Paris was appointed the new incoming Principal at the Avery Elementary School**. I'm excited to announce that after 2+ years of pandemic cancellations, DPS will be bringing back the Aspiring Leaders Academy spring seminar next Tuesday, May 3 from 3:30 - 5:00 PM at the **MIT Endicott House**.

Some School Committee members will remember the top notch educators we've hosted in past Aspiring Leaders sessions including MTA President Barbara Madeloni, Diversity Educator Kalise Wornum, DESE Commissioner Jeff Riley, Teachers 21 President John D'Auria, and Chair of MA Joint Committee on Education Rep. Alice Peisch. Tuesday's session will feature guest speaker and **DESE Associate Commissioner Rob Curtin**. Rob is head of the DESE Center for District Supports, and is also in charge of designing the MCAS Accountability System for all MA schools and districts. He will talk about his own personal leadership journey then give us a window into the future of MCAS and accountability systems in the post-pandemic era. This will certainly be an interesting conversation. All School Committee members are cordially invited to attend.

As the Committee is aware, tomorrow night the Board of Selectmen will consider the approval of two additional MSBA "Statements of Interest" (SOI's) for the **Greenlodge** and **Riverdale** elementary schools. These are a

necessary requirement in the event of a consolidation of the Oakdale Elementary School with either of these buildings. The specific verbiage of this request is very important, and the last step of filing these complete SOI's is the signed letter from our Committee and the Town Clerk. These letters and the SOI's will be submitted to the MSBA by this Friday's deadline. More on this during the Subcommittee Reports portion of tonight's meeting.

Internally within the district we have been discussing the addition of language at the end of all district-issued emails that makes note of the "public record" nature of this form of communication. After consulting with legal counsel, we have proposed the following specific language for email footers:

"When writing or responding, please remember that the Secretary of State's Office has determined that email is a public record. This communication may contain privileged or other confidential information. If you are not the intended recipient, or believe you have received this communication in error, please do not print, copy, re-transmit, disseminate, or otherwise use this information. Also, please indicate to the sender that you have received this email in error and delete the copy you have received." We expect to implement this prior to the end of this school year.

Superintendent's COVID-19 Update


Superintendent Welch provided the following update to the Committee:

Since there was no school in Dedham last week, all schools are working to take account of any new COVID-19 cases that occurred outside of school. This is an imperfect process and depends upon the diligence of parents to continue keeping schools informed when their children test positive. We also know, based on conversations with Director of Health Services Maria Antonuccio and Dedham's Health Director Kylee Sullivan that allergies have been quite active lately and many parents may be believing that these are "allergy symptoms" rather than possible COVID-19.

This week's pooled testing at all schools showed FAR fewer positive test results than the week before our April vacation break. On Monday and Tuesday of this week we tested a total of **300 pools** that included **1416** individuals. We received 3 positive pools out of those 1416 individuals for a percent positivity of 0.20%. 2 of the positive pools were at Dedham Middle School and 1 positive pool was at Avery. One of the positive pools at DMS actually turned out to be a student that had COVID-19 over April vacation and accidentally participated in testing within the 90 "do not test" window. There were **NO POSITIVE POOLS** from ECEC, Oakdale, Riverdale, Greenlodge, and Dedham High School this week.

The slight decrease in cases this week is consistent with reports of slight decreases in schools across the state. Recent wastewater COVID-19 concentrations mirror this cresting and slight downturn of COVID-19 concentrations in wastewater also. This reading has proven to be pretty accurate in predicting future cases 2-5 days in advance. A graph of this week's data from MWRA wastewater is shown below:
