

Supt. Welch went on to discuss the stipends for fall coaches. Other districts are paying their coaches 100% of their stipend pay. The Negotiations Subcommittee has agreed to pay 2/3 of the stipend. Their reasoning is that other districts began their season before Dedham. The Subcommittee discussed 75% of pay vs. 50% of pay. This subject has not yet been discussed at the bargaining table.
