Chair of the Budget Sub Committee Mrs. Butler-Walko thanked the Superintendent Doe and Assistant to the Superintendent for Business and Finance, Mr. LaFrancesca, for their hard work putting together the FY14 Budget which includes a 1.9 increase from FY13, announcing that The School Committee will not be voting on FY14 Budget tonight, but will discuss it.

Michael LaFrancesca presented a PowerPoint Presentation, and Mrs. Doe explained the goals accomplished in the 2012-13 school year which included an iPad Initiative, new District Website, Implementation of <u>Treasures</u> Literacy Program, a Science and Engineering Curriculum for Grade 8, a new Social Studies Curriculum and texts for Grades 6 and 7, and a revised Math curriculum for Grades 7 & 8. Changes include the required obligations to Special Education Out-of-District Tuition and Special Education Transportation. non-personnel, personnel and new positions are additional changes. Mr. LaFrancesca explained the budget calendar between Oct. 1 and May 20, 2013, budget history, budget drivers, and salary breakdown. Mrs. Briggs thanked the Administration and Budget Sub Committee for their hard work, and discussions followed. Powerpoint Presentation on the DPS website.

SUPERINTENDENT'S UPDATE:

MIDDLE SCHOOL- Report cards were distributed for terms 2 on February 1st. Project 351 – 8th grade student Olivia Corrado who was selected by the DMS faculty to participate in Governor Patrick's day of service on January 26, 2013 involving grade 8 students from the 351 cities and town in Massachusetts. DMS Parent Group sponsored a speaker at the middle school who presented on the "Myths of Marijuana". Paul Hallion, retired public school health educator presented to parents from both the middle school and high school. The presentation will be rebroadcast on the Dedham Education Channel.

OAKDALE -Students in grade 4 participated in the NAEP testing on Jan. 30th. Oakdale was randomly chosen along with the Avery School by the DESE to participate in this National Assessment. The students were tested in either Reading or Math.

MATH PROPOSAL:

Superintendent explained the new Math Proposal created by Math Department Chair Kristine Holloran.

To create a new course in grade 9 entitled Algebra 1 – Quadratic Emphasis for students following the college prep pathways in mathematics. In grade 8, Algebra 1 will be taught with a linear emphasis, per the common core standards; this was typically taught in grade 9 in the past. Algebra 1 – Quadratic Emphasis will expand on those concepts by applying them to quadratic and exponential equations. Both courses will also integrate new geometry and probability and statistics standards from the common core. The DESE is strongly suggesting that schools follow the new standards exactly as recommended due to the fact that the new mathematics standards are very rigorous at each grade level. Discussions took place and Principal Gately explained the middle school math curriculum, math enrichment program, and the math lab and challenge lab.

POLICY SUB RECOMMENDATION

Proposal by Mrs. Sullivan on behalf of the Policy Sub Committee that met last week regarding new fees for Band and Color Guard and Transportation Fees:

- -Establish Official Band and Color Guard Activity Fee \$125.00 per person with a family cap of \$500.
- -Bus Fee with increasing bus costs, the proposal is:
- -User Fee cost per student \$260.00 per person with family cap of \$600.00.
- -If payment is not received by August 15th, a penalty fee of \$15.00 will be added (\$275.00 per student).
- -One way cost \$175.00 per student due before August 15th.
- -After August 15th no one way passes issued.
- -Payment Plan 2 payment plan one due by August 15th and the other on or before February 1st.

Mrs. Doe announced that the DEA ratified their agreement yesterday. Teacher's Contract Negotiations were agreed upon with the following terms:

3 Year Agreement Compensation:

Year 1 - 1% cost of living increase

Year 2 – 1.5%cost of living increase

Year 3 – 2 ½ % cost of living increase

- -Additional money in Professional Development for Teachers- Expanding budget by \$5000 for each of 3 terms for a total of \$60,000 in year 3 change occurs.
- -Increasing all coaches and activity stipends in year 3 of the contract by 2 ½ %.
- -Agreed to give additional time to MS and HS Nurses 4 days per diem to process the athletic paperwork to provide additional time.
